





## CORPORATE BOWLING & POOL CHAMPIONSHIP

## 3rd & 4th December 2016 - Prime Time R-City Mall, Ghatkopar

- 1. The event is open to all corporates including public & private limited, public sector, partnerships & proprietorships
- 2. General Terms
- a) All participants have to have a valid company ID proof and must be from the same corporate. Grouping of employees from different corporates (including group companies) is not allowed. In absence of employee id cards, a stamped & signed letter from the HR certifying the bonafides of the participants must be submitted at the time of registration along with govt approved id proof by every participant. Failure to produce the necessary id proof by a player may result in the organizers not allowing the player(s) to participate in the tournament.
- b) Contractual staff can also be permitted to participate as per the discretion of the company subject to them having been associated for a period of at least six months with the company which must be given by the company in writing on its letter head. The contractual staff must possess a valid ID proof in the absence of the company id card.
- c) Organizers decision is final in case of any dispute with regards to the eligibility of a player.
- d) The same employee cannot be a part of multiple teams in the same sport
- e) Lunch / refreshments will be served to all participants as applicable
- f) League cum knockout matches will be played in both the sports. The specific match formats will be released with the schedule. However, each participant is assured of a minimum of 2 games in every category for both the sports.
- g) Trophies & Medals will be given to the top 4 winners in every category for both the sports
- h) Bowling shoes will be provided to all participants. All participants are to carry their own socks. Playing barefoot is not allowed. All other equipment for bowling & pool will be provided by the organisers
- i) Any damage to the infrastructure facilities or equipment or loss of the equipment will be charged to the participants
- j) Basic first aid will be available at the venue. However organizers are not responsible for any injury or accident to the players.
- k) Timings for the matches need to be strictly adhered to. Organizers would not like to give walkovers & a maximum delay of 10 minutes will be allowed from the timing of the match.
  Participants are requested to report at least 30 minutes before their scheduled matches. All

are requested to adhere to the timings so that all matches can be smoothly organized causing minimum delays & inconvenience to participants.

- The match schedules and timings shall be put up on the website <u>www.nsportz.com</u> on 1st Dec 2016. A copy of the same will also be there at the venue. Schedule / draws put up are indicative and subject to change as there could be last minute changes in the teams / players.
- m) The entry fee has to be paid by the last date of the registration which is 29th November 2016. If the fees are not paid by then, the participation of the player(s) will not be treated as confirmed unless expressly approved by Time Zone or NSportz. If such players turn up for the tournament, they may be allowed to participate as an on spot entry subject to availability and will have to pay a 20 % premium over the applicable fees.
- n) The fees are to be paid favouring Time Zone Entertainment Private Limited which will be invoicing the corporate towards the participation fee. The fees are still payable if there is a subsequent withdrawal by the company after the last date for entry closes or at the tournament or due to a no show for any reason. A company will be allowed to change player details till the start of the tournament.
- o) Fees once paid will not be refunded due to any reason except if the tournament is not conducted due to any reason.
- p) The organizers hold the right to postpone any match under any exceptional circumstances as per their discretion
- q) Standard Rules of both the sports are applicable unless otherwise specified
- r) Participants are expected to play the tournament in the right spirit. No arguments with the referees or organisers will be entertained. In case of any disputes for any reason, the decision of the referees & or organisers is final and is binding on the participants.
