Prospectus

1. The event is open to all corporates and corporate employees including private, govt / semi govt companies and PSU's .

There are three basic championships

A. Corporate Super Mixed Team Event

- This will consist of team championships between 16 corporate teams (can be expanded to a larger number at the organizers' discretion) on a first come first serve basis.

There will be 5 matches played between two teams in the order as under

- ✓ 1st Men's Singles
- ✓ Ladies Singles
- ✓ Men's Doubles
- ✓ Mixed Doubles
- ✓ 2nd Men's Singles

- The teams will be categorised into groups of 3 - 4 each & each team will play group matches with other teams in the group in the above 5 categories. Each match will be best of 3 games in the league stage. Knock out matches will be played best of 5 games.

- Minimum 8 teams are required to conduct the Corporate Super Team event.
- All 5 matches are to be compulsorily played in the league stage as each match gives 10 points to the winner.
- Minimum number of people for team registration is 3 and maximum number is 5.
- All team members have to be from the same corporate. They cannot be mixed at a corporate group level. One company can nominate more than 1 team.
- At the end of the group stage matches between the various teams, the top 1 or 2 teams in the group in terms of points will move over to the knock out stage.
- In case of tie in points between two teams at the end of the group stage, the team which has won the match between the two teams will get precedence over the other. In case of a 3 way tie, the teams will be ranked in the descending order of game difference (games won minus games lost). If still equal, the difference of points will be considered.





- The knockout matches (quarter finals, semi finals & finals as applicable) will be played on a similar basis however, all 5 matches need not be played in case of a clear winner after the 3rd or 4th match.

B. Corporate Super Mens Team Event

- This will consist of team championships between 16 corporate teams (can be expanded to a larger number at the organizers' discretion) on a first come first serve basis.

There will be 5 matches played between two teams in the order as under

- ✓ 1st Men's Singles
- ✓ 2nd Men's Singles
- ✓ Men's Doubles
- ✓ 1st Reverse Men's Singles
- ✓ 2nd Reverse Men's Singles
- The teams will be categorised into groups of 3 - 4 each & each team will play group matches with other teams in the group in the above 5 categories.
- Each match will be best of 3 games in the league stage. Knock out matches will be played best of 5 games.
- Minimum 12 teams are required to conduct the Corporate Super Team event.
- All 5 matches are to be compulsorily played in the league stage as each match gives 10 points to the winner.
- Minimum number of people for team registration is 2 and maximum number is 4.
- All team members have to be from the same corporate. They cannot be mixed at a corporate group level. One company can nominate more than 1 team.
- At the end of the group stage matches between the various teams, the top 1 or 2 teams in the group in terms of points will move over to the knock out stage.
- In case of tie in points between two teams at the end of the group stage, the team which has won the match between the two teams will get precedence over the other. In case of a 3 way tie, the teams will be ranked in the descending order of game difference (games won minus games lost). If still equal, the difference of points will be considered.

- The entry fees are Rs 2000 for singles events & Rs 3000/- for doubles (total for both players) plus any applicable service tax & is payable in the name of 11even Sports Pvt Limited

2. General Terms





- a) All participants have to have a valid company ID proof. In absence of the same a stamped & signed letter from the HR certifying the bonafides of the participants must be submitted at the time of registration. Failure to produce the id proof by a player may result in the organizers not allowing the player(s) to participate in the tournament.
- b) Contractual staff can also be permitted to participate as per the discretion of the company subject to them having been associated for a period of at least six months with the company which must be given by the company in writing on its letter head. The contractual staff must possess a valid ID proof in the absence of the company id.
- c) Lunch / refreshments will be served to all participants as applicable
- d) Standard Rules of Table Tennis as accepted by 11even Sports will be followed
- e) Organizers decision is final in case of any dispute including eligibility of a player.
- f) Basic first aid will be available at the venue. However organizers are not responsible for any injury or accident to the players.
- g) Timings for the matches need to be strictly adhered to. Organizers would not like to give walkovers & a maximum delay of 10 minutes will be allowed from the timing of the match. Participants are requested to report at least 30 minutes before their scheduled matches. All are requested to adhere to the timings so that all matches can be smoothly organized causing minimum delays & inconvenience to participants.
- h) The match schedules, draws and timings shall be put up on the websites www.msdtta.org & www.nsportz.com from 15th September 2016. A copy of the same will also be there at the venue. Draws put up are indicative and subject to change as there could be last minute changes in the teams / players.
- i) The entry fee has to be paid by the last date of the registration which is 13th September 2016. If the fees are not paid by then, the participation of the player(s) will not be treated as confirmed unless expressly approved by 11even Sports or NSportz. If such players turn up for the tournament, they may be allowed to participate as an on spot entry subject to availability and will have to pay a 20 % premium over the applicable fees on the spot.
- j) The fees are to be paid favouring 11even Sports Pvt Limited which will be invoicing the corporate towards the participation fee. The fees are still payable if there is a subsequent withdrawal by the company after the last date for entry closes.
